Dear Correspondent:

This is to acknowledge receipt of your correspondence regarding payment of restitution as authorized by the Civil Liberties Act of 1988.

The Attorney General authorized the establishment of the Office of Reparations Administration within the Civil Rights Division. The Office of Reparations Administration is responsible for locating eligible individuals and subsequently making payment to them. In order to identify eligible individuals, we are making full use of all known records of the United States Government including those held by the National Archives. We are also in the process of developing regulations to implement the program.

Once determinations are made, eligible individuals will receive a notice. However, because it is estimated that there are approximately 60,000 people who will be eligible, we anticipate that, at the earliest, notifications will begin to be made in late-1989. In the interim, your name and address have been placed on the mailing list and we will be sending you additional information as it becomes available.

We regret that the large volume of mail on this matter does not permit a more specific response at this time and apologize for any inconvenience this may cause you.
