

Declaration of Homestead

HEAD OF FAMILY

Know all men by these Presents: That I, Fumio Takano

do certify and declare that I am the head of a family, that I do now, at the time of making this declaration actually reside with my family, consisting of Yoneko Takano, wife, Kazuo Robert Takano, child, Itsuhei Takano, father, and Tomoye Takano, mother.

on the land and premises described as follows, to-wit: Lying and being in the County of Los Angeles, State of California, and bounded and described as follows:

Lot 21, in Block 11, of G. W. Morgan's Sycamore Grove Tract, as per map recorded in Book 11, Pages 57 and 58, Miscellaneous Records, in the office of the County Recorder of said County

That it is my intention to use and claim the said lot of land and premises above described, together with the dwelling house.... thereon, and its appurtenances, as a Homestead and I do hereby select, declare and claim the same as a homestead.

That the actual cash value of said property I estimate to be \$ 6,000.00

[1] That no former declaration of homestead has been made.

In Witness Whereof, I have hereunto set my hand and seal, this 15th day of April, nineteen hundred and Forty-eight

Such declaration of homestead may further contain a statement of the character of the property sought to be homesteaded with sufficient detail that it is a proper subject of homestead, and that no former declaration has been made, or, if made, that it has been abandoned. If this statement is made the verification must also be made before the Notary Public.
