Local registrars must mail the original certificates for each month to the State Registrar at Sacramento, California, on or before the fifth day of the following month.

EXTRACTS FROM REGISTRATION LAW (CONDENSED).

Political Code, Section 3074 to 3083, or Chapter CX, Statutes of California, 1905.

Political Code, Section 3076. All persons who perform the marriage ceremony in this State shall, within three days after the ceremony, file with the County Recorder, as local registrar, this certificate, properly filled out, for the marriage performed by them.

Sec. 3082. Any officer or person who fails, neglects or refuses to perform any of the duties imposed upon him under the law for the registration of marriages or by the instructions and directions of the State Registrar, shall be deemed guilty of a misdemeanor.
