"We haven't had any recent fires. so why not get rid of our fire department." someone once said.

His reasoning is way out of line, you say. We agree. This kind of complacent thinking is dangerous. Okay, but how come we talk about a fire department, you ask? What's it got to do with you?

It has plenty to do with you. There is a fire department that you've got to keep going.

The JACL and its legislative arm, the Anti-Discrimingtion Committee, is your fire department. It's a super fire department because it not only puts out fires and prevents conflagrations, but does a whole lot more for the Nisei and Issei in America.

The JACL-ADC Fire Chief is Mike Masaoks, National Legislative Director. The Washington department and the branch departments throughout America have used modern American apparatus and fire-fighting techniques -- representations before Congress, courts of law, and government and private groups, and public relations and community education through newspaper and magazine editorials and articles, radio and television broadcasts. and speaking engagements by JACL-ADC board and staff members.

Here are the fires and the smoldering coals of the pest four years which the JACL-ADC has extinguished:

Nullified the effectiveness of the California Alien Land Law * Helped wipe out the denial of commercial fishing licenses to Isse! * Expunsed the Alien Land Law in the State of Utah * Helted the deportation and separation from their families of some 2.000 Issei * Restored government vested property to Nisei strandees * Eliminated the requirement of "limited passports" to Hawaiian Issei visiting the mainland.

Removed racial discrimination in cameteries * Prevented the production of anti-Japanese recist motion pictures * Eliminated, with other groups, the ban against non-whites by the American Bowling Congress * Joined in court action which outlawed racial restrictive covenants * Prevented the passage by Congress of bills which would have deported every Issei in America and another that would have confiscated the property of all Issei.

JACL-ADC's fire-fighting service has enhanced your community status:

Passage of the Evacuation Claims Bill * Legislation permitting the filing of claims for losses on contraband property * Another amending the CI Brides Bill to permit Japanese vives to enter the United States * And still another granting naturalization for Issel serving in the Armed Forces * Compensation for fire losses suffered by residents of Poston and Manzanar * Acceptance of Nise! into all branches of the Armed Forces without segregation * Extension of filing date for yen deposit claims * Reopening of mail and percel post delivery to Japan and Okinawa.

The Southern Celifornia branch of the JACL-ADC not only combats local discriminatory fires. but renders many community aids:

Welfare service and referral for the aged, needy. blind, orphaned unemployed and disabled * Informational and advisorial services on many problems common to Japanese Americans --- naturalization, deportation, strandees, GI brides, evacuation claims, social security, unemployment and other welfare problems * Alien registration service, assistance in filing naturalization papers, and sponsorship of citizenship and Americanization classes.

A Christmas Cheer program to bring Yuletide warmth to destitute families by the JACL Club Service Bureau, which coordinates the city-wide club activities of Nisei and Sansei * Participation with other civic groups in stamping out embers in the general field of civil rights * And a multitude of miscellaneous personal services to all who ask JACL's help.

There are still many fires, sparks and smoldering embers that must still be stamped out. But you and your community will be safer with an alert and ready JACL-ADC fire fighting organization. Still smoking:

- Issei are still denied citizenship. The JACL-ADC must wipe out racial restrictions in our naturalization lave.
- The Oriental Exclusion Law of 1924 must be repealed. as must the 37 year-old Alien Land Law of California
- The bogged-down Evecuation Claims program of the Dept. of Justice must be liberalized and expedited.
- A vigorous public relations program must be pursued to retain end strengthen favorable public sentiment.
- Representations by the JACL-ADC must constantly be pressed at public and private levels to attain equality of status, treatment and opportunity.

No fire department can operate effectively without a crew and equipment. The best fire department consists of a network of station houses financially supported by the community. The JACL-ADC is such a fire department that needs your financial support. Your welfare and the welfare of your community are at stake.


